Through our membership and support services the NI Sports Forum benefits around 480,000 individuals involved in sport and recreation. It is the breadth of our members and representation that lies at the heart of the Northern Ireland Sports Forum and is what makes us unique.

FOREWORD FROM CHAIRPERSON

In my second year as the Chairperson of the Northern Ireland Sports Forum I am pleased to see that sport has returned in all forms and that the people of Northern Ireland are having the opportunity to enjoy sport, exercise, connect with others, compete and enable others to benefit from sport and activity.

The past year for the Sports Forum has been largely focused on supporting our members with the challenges they face as we emerge from Covid-19. The sector is facing economic and social challenges, which could have long term impacts on clubs and NGBs. Some of the challenges faced are the increase in the cost of living & utility bills, volunteers not returning to sport to the same level pre Covid-19, difficulty in recruiting board members, some facilities have not re opened or are less accessible for sports clubs as pre pandemic. The rise in utilities is going to make this more challenging and NGBs and clubs may be faced with using reserves to maintain normal activity. We continue to advocate for the sector to enable sport to operate as normal.

The past year has reinforced the relevance of sport to NI for health and wellbeing, social connection, and community engagement. This provides opportunities for our sector, but the challenge of meeting demands with the difficulties we currently face.

In January 2022 Ciaran Kearney left the Sports Forum to take a new opportunity with the GAA. I was both disappointed to lose Ciaran from the Sports Forum but delighted for him on his new role. I had the pleasure of working with Ciaran as both a board member and recently as the Chairperson. Ciaran was committed to supporting our members and to advocating for the Sports Sector. Ciaran was liked and respected by our members and our partners and was key to the success of the Sports Forum over the past 7 years. In February, we recruited Richard Honeyford as the Sports Forum's Executive Manager. Richard was previously the Chief Operating Officer for RYANI where he was employed for 16 years. Richard comes with a breadth of knowledge of the sports sector and understands the challenges we currently face. Richard has embarked on the role with engagement with our members and partners to understand the needs of the role whilst delivering the business objectives of the Sports Forum. I am looking forward to working with Richard in the years ahead.

In September we secured funding from the Department for Communities Start Here programme which enabled us to build capacity in the team by recruiting two new roles. Niamh MacManus takes on a new role as the Member Services Officer and Natalie Niederman joins us as the Inclusive Participation Officer (Female Sports Forum). These roles will enable our Executive Manager, Richard Honeyford to provide additional support to our members and to explore new opportunities to benefit our members.

This year saw the publication of Active Living, the new Sport and Physical Activity Strategy for Northern Ireland and its vision of "a Lifelong involvement in sport and physical activity will deliver an active, healthy, resilient, and inclusive society which recognises and values both participation and excellence". Sport NI's Corporate Plan was also launched this year titled The Power of Sport with its Mission Statement "We are passionate about maximising the power of sport to change lives. By 2026, we want the power of sport to be recognised and valued by all". We welcome both strategic documents which provide sport with a vision for the coming years. Last year the board of the Sports Forum started the process of developing its next strategic plan. We will shortly be engaging with our members to complete this process.

The Commonwealth Games provided us with the joy of watching athletes from Northern Ireland compete on the Commonwealth stage. This Commonwealth Games presented challenges to the athletes and coaches Rhys McClenaghan, Ewan McAteer and Eamon Montgomery competing at the Commonwealth Games, Birmingham 2022.

EXECUTIVE MANAGER'S REPORT

It has been a privilege to take up the role as Executive Manager at the Northern Ireland Sports Forum. Over the course of my first five months, it has been great to meet so many motivated individuals across a wide range of sports and backgrounds. A key part of my work to date has been to engage, listen and get up to speed on aspects facing the sector; looking to assess priorities that the forum can continue to help organisations with, engage with government on key matters and to get our two new roles in place.

I would like to take this opportunity to thank Ciaran Kearney for his 7 years at the NI Sports Forum, developing and expanding its reach and remit. Also to Gordon Reid who kept continuity over the course of five months as the Executive Manager recruitment process took place. Both remain engaged and supportive where questions have arisen, which is much appreciated.

2021-22 was another year where the pandemic was still being felt across the sporting sector. A number of sports had not returned to activity until the spring

and many faced new challenges such as increased rental costs or gaining access to facilities. The NI Sports Forum helped support these sports, continuously raising issues with MLAs and Ministers in order to help get all sport back on track. It has remained a difficult environment to operate in with volunteering, finances and participation impacted.

Funding support packages from the Department and SportNI were key to helping sports bodies and clubs survive Covid financial impacts. The NI Sports Forum advertised these packages wherever possible, sharing and highlighting across our platforms. The first half of the year saw updates to our funding webpage on an almost weekly basis, while this then reduced to monthly come October 2021.

The Sports Forum also remained engaged in multiple consultations across a broad range of areas that were impacting on sport, including Charity Legislation, Gambling Legislation and the Department of Communities Strategic Plan, to name a few. We presented to the Communities





Committee on gambling legislation and female sport on International Women's Day. Our Member Services were in high demand, especially as sports restarted post covid, with 204 AccessNI Checks completed, governance reviews/ advice for eight sports and our Board Recruitment Programme taking off with enquiries once again. Following the Pandemic, this appears a key area of need in the sector with many organisations seeking help to fill Board posts.

Our events continued to be well attended and, of note, the annual Sports Law Conference saw a record number join online. The NI Sports Forum also delivered a number of support events in areas such as disputes resolutions, finding funding and Sports for Business.

Thank you to our Corporate Partners and funders who help and support the work of the NI Sports Forum, including SportNI, Department for Communities, Sports Law NI, 2into3, Catherdral Eye Clinic and

Kingsbridge. This investment and resource ensures the ongoing work of the forum and supporting our members.

I would like to thank the NISF Board for their continued support and advice while I settle into the role. Ashley Hunter, Chair has been of enormous help and advice as I look to get up to speed on matters affecting the sector. Thank you also to our Bookkeeper, Sharon Crossan and to all the Board and subcommittee members who put in such hard work and commitment in support of the Forum's work.

Looking forward, with our two new roles in place, we will see progression of our Member Services and the Female Sports Forum once again and I hope we will be able to enhance and develop our services on behalf of members.

OVERVIEW OF THE YEAR'S WORK & ACTIVITIES

COVID 19 RESTRICTIONS

2021-22 still saw restrictions on sport and activity early into the year. These gradually allowed a return to activity for most sports, but left an ongoing constraints for others, particularly indoor sports. The NI Sports Forum spent considerable time providing advice. guidance and support to members. We looked to engage with SportNI and Department of Communities, feeding back concerns and working closely on communicating guidance as it was issued. A process of ensuring communication towards non-funded bodies as agreed with SportNI to ensure messaging was provided as quickly as possible without. NISF has also provided bespoke advice and guidance to a number of organisations by various means. By the Autumn 2021 ongoing issues securing venues for indoor sports was raised with local authorities.

MEDIATION AND DISPUTES

The NI Sports Forum engaged with Sports Resolutions UK regarding the delivery and provision of this service. NISF hosted a webinar on Reviews and Investigations in Sport. The Sports Law Conference was also successfully hosted, with a record level of attendance online. We reviewed Constitutions /Governing Documents for eight bodies to help avoid potential conflicts. Thank you to Keith McGarry (Sports Law NI) and Ken Nixon for their ongoing support and advice and, of course, the Law society NI, for the delivery of the annual Sports Law Conference.

BOARD RECRUITMENT PROGRAMME

NI Sports Forum engaged with six organisations seeking to gain 33 candidates and place individuals. If this is something your organisation wishes to access or if you are aware of individuals who may wish to provide an expression of interest for potential positions, please contact us.

ACCESS NI

The NI Sport Forum completed 204 Access NI checks from 20 bodies with four members joining the list in year. The requirement for checks increased substantially once again following a return to activity. If this is a service that your organisation may benefit from, please contact us.

REPRESENTATION

Representing our members and the wider sector has been of paramount importance over the 2021-22 year. We were regularly at the forefront of advocating for financial support from government and Sport NI. We engaged extensively with MLAs, political parties and governmental bodies to ensure the impact of COVID-19 was recognised and support schemes were put in place. We also held three meetings of the All Party Group on Sport and Recreation, raising wider issues such as Stadium Rates and ongoing challenges for indoor sports activity.

In the lead up to elections, the NI Sports Forum developed a Manifesto for Sport with 4 Big Asks. This was issued to five main parties with request for further engagement and is available on our website.

As always we do encourage members to get in touch regarding any of these groups we represent you on and if there are ways that you believe we can improve our representation or communicate your needs more appropriately.

CONSULTATIONS

Alongside continued communications with the Department for Infrastructure on the Road Closures Order, we engaged with various departments on consultations



including the SportNI Corporate Plan, the Strategy for Sport and Physical Activity from DfC, Betting, Gaming, Lotteries and Amusements (Amendment) Bill, the Draft Environment Strategy, Charities Review and DoJ Abuse of trust consultation. We presented to the Committee for Communities on the Gambling legislation review and on the work of the Female Sports Forum on International Women's Day.

EVENTS

Business of Sport event in March was the first face to face event in two years, attended by 30 and across the sector. Presenters included IFA, Ulster Rugby Ulster GAA, and Bank of Ireland. Within the year, 70 attendees gained shared knowledge from the 2into3 funding seminar. We held ongoing webinars and support for members as needs arose.

NEW MEMBERS

We would like to welcome the Ulster Rifle Association as a new member of the Sports Forum. Our new website provides significant information on the benefits of becoming a member of NI Sports Forum, the steps about how to do so and the costs associated with membership. Membership for the forum is a vital part of our work, ensuring we represent and support the sector as much as possible.

FEMALE SPORTS FORUM

Unfortunately the cessation of funding of the Female Sports Forum in 2020 led to activity stopping at a time when it had gained good momentum and when Covid 19 would adversely impact on female participants and leaders in the sector. The NISF has sought other avenues of funding to reassess this and thanks to the Department of Communities Start Here programme have secured a post to reinvigorate the Female Sports Forum in 2022.

SAFEGUARDING SUPPORT

NI Sports Forum has engaged with the NSPCC Child Protection in Sport Unit to provide support for non-funded members. Ongoing meetings have taken place to understand support that can be offered and to support appropriate bodies. NI Sports Forum has engaged with nine member bodies in the year. Whilst certain safeguarding requirements are placed on funded bodies as part of Sport NI investment, it is important that all sports organisations have adequate safeguarding measures in place. In collaboration with the CPSU, NI Sports Forum provided an overview of the steps that members should be taking to safeguard their members and participants. We are now entering the final year as part of a three year programme and any member who would like support in this area should get in touch.

GOVERNANCE SUB-COMMITTEE

CHAIRPERSON'S REPORT

2021-22 has been a reasonably quiet year for the Governance Sub-committee as we have concentrated on a return to normality post-COVID. The key focus has been the agreement of the operational plan.

There have been some changes to the committee due to Elaine Reid stepping down from the Board. I wish Elaine every success in her new position with Sport NI and look forward to continuing to work with her in this context. I am delighted that Gordon Reid has once again agreed to remain on the Committee as a member, providing his vast knowledge and passion for the area of sports governance and his exceptional attention to detail.

There has been significant personnel changes within the Forum and I am delighted with the appointment of Richard Honeyford to the post of Executive Manager, With Richard's vast experience of the sector and knowledge of governance issues in sport, Richard has hit the ground running in a short space of time and is already impacting positively on organisational governance. I wish Ciaran Kearney success in his new post with the GAA and we are all aware of the progress made by the NI Sports Forum under Ciaran's leadership, particularly through the COVID crisis. I wish to put on record my personal thanks to Ciaran for his assistance with all governance aspects of the NI Sports Forum. In addition we welcome Niamh MacManus continuing her employment with the Forum and more recently Natalie Niederman to the role of Inclusive Participation Officer.

Whilst the formal operation of the committee has been limited, there have been some key highlights:

 Continuing to monitor progress against the Strategic Plan and operational targets for the year;

- Full review of the Operational Plan to consider factors such as the agreed work plan with Sport NI, and the needs of our members as conveyed to us via a members survey:
- Continued review of the Board structure and governing documents to provide protection to the essential and skilled role of Treasurer in the voting processes; and to align the terms office for the Board members to ensure staggered elections and therefore protecting the continuity of the Board. Proposals have been made to the members to action these changes.

In 2022/23 the Forum will enter a crucial planning phase with the Governance Committee leading on the process of developing a new long term strategy for the future of the organisation. Terms of reference have been agreed for this essential piece of work and we hope to see progress in the coming weeks where there will be some key engagement opportunities with our members.

In conclusion, 2021/22 has seen significant change in the NI Sports Forum however from a governance perspective, things have been stable. As we enter the planning phase for the new strategic plan, these are positive times for the Forum and we have a great opportunity to create a clear pathway for our future and ensure we continue to make a significant impact for our members.

COMMUNICATIONS SUB-COMMITTEE

It was all change for the NI Sports Forum in early 2022, welcoming our new Executive Manager Richard Honeyford after colleague Ciaran Kearney left for pastures new. Whilst the personnel changed, the focus on supporting our members and raising awareness of the issues facing the sector did not.

The Communications Sub-Committee supported the NI Sports Forum and the Board in this activity, engaging and informing on a wide range of areas on behalf of members.

The effects of the pandemic are still being felt by clubs across the island of Ireland, add to that an NI Assembly Election, followed by a prolonged period of political stagnation, it has been another challenging year. In recent months, the cost-of-living crisis has severely impacted society and our members are similarly affected.

In spite of the challenges our members and the NI Sports Forum have done a lot of great work, engaging, and informing on a range of issues, developing partnerships, and putting in place initiatives aimed at supporting the sector.

FINANCE SUB-COMMITTEE CHAIRPERSON'S REPORT

Over the course of the year the Finance Sub-Committee continued to meet virtually to review quarterly management accounts and budgets, review future projections, provide financial oversight to grant applications and recommend approval of the Financial Statements to the Board. In addition, the committee regularly reviews the Membership list as regards slow payers and potential deletions, with new member applications approved at board level. The committee monitors salary scales as well as liaising with the NI Sports Forum payroll and pension providers regarding possible/ actual legislation changes.

The past 12 months saw a return to a more positive financial position for the Sports Forum with the successful return of the Sports Law Conference in a virtual format along with opportunities to host in person events and develop both new and existing partnership arrangements. This was reflected in the Sports Forum recording a healthy surplus in the annual accounts for 2021-22. This was a welcome result after a difficult year financially in 2020-21. Robust previous financial years enabled the Sports Forum to manage the cashflow impact of that deficit and ensured NI Sports Forum was well positioned and resourced to provide for our members and resume activities at the appropriate time.

The outlook for 2022-23 is more conservative due to a number of factors. With some staff changes, particularly the welcome appointment of Richard Honeyford as the Sports Forum Executive Manager. it is set to be a vear of consolidation and development, which I am confident will have a positive impact financially for future years.

Much thanks goes to the members of the Finance Sub-Committee for their support and smooth operation of the financial procedures all year. Special recognition must go to former Executive Manager Ciaran Kearney for all his work and invaluable support in the past number of years. Thanks must also go to Gordon Reid for his support as interim Executive Manager, Sharon Crossan who as always ensured financial procedures were adhered to and transactions were carried out efficiently; and last but not least Richard Johnson who continued to provide a valuable contribution to the Finance Sub-Committee after stepping down from his role as Sports Forum Chair.
